KEY AMENDMENTS TO THE MALAYSIAN CODE ON CORPORATE GOVERNANCE

We are pleased to inform you that the Public Practice Committee is organising an Evening Talk cum Hi-Tea on *Key Amendments to the Malaysian Code on Corporate Governance.* The event is scheduled for March 28, 2008, from 4:00 p.m. to 6:30 p.m. at The Legend Hotel, Kuala Lumpur.

The Malaysian Code on Corporate Governance (Code), first issued in March 2000, marked a significant milestone in corporate governance reform in Malaysia. It codified the principles and best practices of good governance and described optimal corporate governance structures and internal processes. The mandatory reporting of compliance with the Code has enabled shareholders and the public to assess and determine the standards of corporate governance by listed companies.

The Evening Talk is intended to inform you of the key amendments to the Code which are aimed at strengthening the board of directors and audit committees, and ensuring that the board of directors and audit committees discharge their roles and responsibilities effectively.

The Institute has invited Ms Wong Sau Ngan, General Counsel of the Securities Commission, to present a briefing on the key amendments to the Malaysian Code on Corporate Governance. We have also invited Ms Yew Yee Tee, Head of Issuers in Rule Development and Advisory Department, Bursa Malaysia Berhad, to be a panel member. The Evening Talk will be chaired by Mr Sam Soh Siong Hoon, Chairman of MICPA's Public Practice Committee.

Profile of Panel Members

She joined Bursa Malaysia (previously known as Kuala Lumpur Stock Exchange) as a legal manager in 1999.

Ms Yew graduated with a Bachelor of Law (Hons) degree from University of Malaya. She practised as an Advocate and Solicitor of the High Court of Malaya with Skrine (previously known as Skrine & Co) in Malaysia. During her years of practice, she was involved in litigation work before switching to corporate and conveyancing.
